

Examples of information returns include, but are not limited to, the following.

- * Form 1098 (home mortgage interest), 1098-E (student loan interest). 1098-T (tuition)
- . Form 1099-C (canceled debt)
- Form 1099-A (acquaition or abandonment of secured property)




East Aurora Varsity Cross Country Course
